## The "CCCC" of What We've Been Doing

#### Charitable Status

Since Fall 2021, CCCC has actively monitored charitable status, speaking out against any attempts to politicize it, which would put any charity with different views or beliefs than the government at risk. A spring Senate Committee report about the sealing industry recommended revoking charitable status for organizations sharing misinformation or disinformation. CCCC takes no position and has no comment on sealing; however, we are always concerned about politicizing charitable status and voiced that concern in a letter to several cabinet ministers.

#### Charter Rights

Religious charities should have equal access to public spaces. That is the core of the issue in a court case against the Quebec government. A religious organization rented a government-owned facility for a conference, but the Minister of Tourism later cancelled the contract explaining that the event was against the fundamental principles of Quebec, which is resolutely pro-choice. The event was unrelated to pro-life or pro-choice issues. CCCC has applied to jointly intervene in this case to support robust protection of religious freedom.

#### Conferences

The International Center for Law and Religion Studies in Utah hosts an annual International Law & Religion Symposium. We were invited to speak in a panel presentation at this year's Symposium, "Religious Freedom as a Tool for Peacemaking" where delegates from around the world gathered to discuss how freedom of religion models peacemaking by accepting and respecting fundamental disagreements, and how religious freedom has brought benefits into public life that might not otherwise exist.

We continue involvement with the Ontario Bar Association's Charity and Notfor-Profit Law Section, as well as the Canadian Bar Association Charities and Notfor-Profit Law Section. Why? To ensure there is a faith-based perspective at the table for submissions, policy priorities and discussions. We also continue representing you in our consultations with CRA in the Technical Issues Working Group. Through involvement in legal and government advisory committees, we stand boldly for the Christian charitable sector, providing input on policies and priorities that impact our community.
